Article 1 Introductory Provisions

This Dean's Decree supplements RD/04/19 - Timetable of teaching and events related to teaching at the Faculty of Applied Informatics (FAI) of Tomas Bata University in Zlín (TBU) and regulates the organization of education in the summer semester of the academic year 2019/20 on the grounds of the declaration of an emergency in the Czech Republic and an emergency measure issued by the Ministry of Health to protect the population and prevent the risk of the emergence and spread of COVID-19.

Article 2 Compensation for teaching in laboratories

Teaching in laboratories with practical measurements in the summer semester of the academic year 2019/20 will be provided as follows:

- Teachers who offer tutoring in laboratories with practical measures during the summer semester of the 2019/20 academic year will commission students to work out a seminar paper of the appropriate scope. Thematically, the seminar papers will be focused on reflecting on the problems of laboratory exercises.
- Teachers submit their seminar papers electronically by Friday, 17th April 2020, at the latest. Students will present their seminar papers electronically by Friday 22nd May 2020 inclusive.
- Teachers will try to help students with the completion of these seminar papers, primarily through online consultations.
- Based on the seminar papers and other results already achieved by students before the interruption of practical lessons, students will be given credit.

Article 3
**A timetable of teaching the final years of a bachelor
and a Master's degree**

The following timetable is set for the final year students of the bachelor and master degree in the summer semester of the academic year 2019/20:

- On-line lessons in the summer semester will be completed on Saturday, May 9th 2020.
- The regular examination period will start on Monday, 11th May 2020, and will be extended until Saturday, 15th August 2020. Due to the extraordinary extension of the regular examination period, the deadline for the correction examination period is not set. During the regular examination period, the lecturer will provide a sufficient number of exam dates.
- Testing will be made possible on-line or regularly as soon as extraordinary measures of the Ministry of Health and regulations of the Czech Republic permit. Teachers will ensure a sufficient number of consultations, if necessary, to successfully cope with an emergency. Teachers will choose between on-line and contact examinations and will inform students about the selected form of examinations.
- Elaboration of practical parts of BP/DP related to work in laboratories will be possible from Monday 20th April 2020 to Saturday 15th August 2020 following the extraordinary measure of the Ministry of Health and the Government Order of the Czech Republic.
- Closing of study obligations and submission of the BP / DP together with the application for the State Final Examinations will take place in the week from Monday 10th August 2020 to Friday 14th August 2020. Exact deadlines will be set by the relevant institute, guaranteeing the given field of study.
- State final exams will take place from Monday 24th August 2020 to Friday 11th September 2020, according to the schedule of state final examinations for individual study branches.

Article 4
**A timetable of teaching the first and second years of the bachelor
degree and the early years of the master's degree**

Students of the first and second years of the bachelor's degree and the first years of the master's degree, respectively students who are not expected to complete their studies in the academic year 2019/20 are scheduled as follows in the summer semester of the academic year 2019/20:

- On-line lessons in the summer semester will end on Saturday, 16th May 2020.
- The regular examination period will start on Monday, 18th May 2020, and will be extended until Saturday, 5th September 2020.
- The correction examination period is set from Monday 7th September 2020 to Saturday 19th September 2020.
- During the regular and corrective exam periods, the teacher will write a sufficient number of exam dates.
- Testing will be made possible on-line or regularly as soon as extraordinary measures of the Ministry of Health and regulations of the Czech Republic permit. Teachers will ensure a sufficient number of consultations, if necessary, to successfully cope with an emergency. Teachers will choose between on-line and contact examinations and will inform students about the selected form of examinations.

Article 5
Final Provisions

The provided timetable is only a general one and depends on the current restrictions of the Government of the Czech Republic issued to protect the population and prevent the risk of the occurrence and spread of the disease COVID-19. If the regulations are amended, the timetables may change further.

This decree cancels and replaces RD/09/20 and is valid until further notice.
